As part of the Provincial State of Emergency, the BC government is taking steps to protect essential services on Vancouver Island and the Lower Mainland through restricting fuel. Island Health is undertaking planning to reduce our fuel use wherever possible, and is asking staff to do their part.

For most medical staff, 30 litres of fuel per fill will be more than sufficient to carry out work functions. In very limited circumstances, medical staff may have to drive personal vehicles significant distances for work purposes and may be eligible to receive a credentialing letter to allow for exemption from the 30L fuel limit. Please note that work purposes means driving between work locations; driving from home to work does not qualify.

Vaccine administration errors can include wrong injection sites on the body, patients younger than approved (updated to 5+ year olds being approved), two doses given too close together, and higher dose than authorized.

- [Clinical Practice Guide for the Use of REGEN-COV in Inpatients with COVID-19](#)

This document explains COV (casirivimab + imdevimab) is RECOMMENDED for inpatients who are: Hospitalized with a confirmed COVID-19 infection and severely ill from symptoms and who can receive REGEN-COV within 10 days of symptom onset and are seronegative for COVID-19 anti-spike antibody as confirmed by serological testing within the 10-day symptom window, irrespective of COVID-19 vaccine status or, if serology results are delayed, be very likely to be seronegative due to being.
