
- Spoken-word artist Shane Koyczan pays tribute to health care workers

- Additional fit testing starts this week
 - The Occupational Health and Safety Department is offering additional drop-in Fit Testing Clinics, at many of our acute care sites commencing on March 22, 2022.
- <u>Set up y our Self-Service Password Reset service</u>
 - Save time by using the new Self-Service Password Reset (SSPR) tool which was launched in mid-March. SSPR allows you to reset forgotten Window/Network passwords on your own and unlock your account without the need to call the Service Desk and wait for assistance.

COVID-19 Updates:

• <u>Update to Communicable Disease Control Manual, Chapter 1: Communicable Disease Control: COVID-19 Interim Guidelines</u>

The BCCDC COVID-19 Interim Guidelines were updated to include a section on the effectiveness of contract tracing in the context of current transmission, information on MHO considerations for declaring outbreaks in long-term care facilities, and an additional appendix on outbreak control measures. Changes are outlined in more detail in this Summary of changes: Admin Circular.



• BC COVID-19 Lessons Learned Review

The Province is launching an independent review and public consultation on its operational response to COVID-19, to better inform preparations and response to

future emergencies. Island Health values your input and would like to know what aspects of the B.C. government's response to COVID-19 from March 2020 to now you think worked well.

• <u>Updated MOH Guidance Document: Overview of Visitors in Long-Term Care and</u> Seniors' Assisted Living and Posters

This Ministry of Health guidance document is updated to include as of March 18, all visitors will be allowed at long-term care and seniors' assisted living facilities. All visitors must show proof of vaccination before visiting a long-term care or seniors' assisted-living facility. Proof of vaccination is not required for: Children under the age of 12, People with an approved medical exemption, Compassionate visits related to end-of-life.

- Rapid tests for people 18+ available at pharmacies
 Starting Wednesday, March 23, 2022, rapid antigen test kits will be available to people aged 18 years and older through community pharmacies.
- What to do after your COVID-19 test

BCCDC handouts for people about self-isolation after a test and for people who test positive were updated with the recent changes to self-isolation and information on managing their illness. This is relevant to the general public and medical staff at Island Health. Topics include: Self isolation If you test negative or positive, Returning from travel outside of Canada and more.

• <u>COVID-19: Infection Prevention and Control (IPC) Considerations for MHSU</u>
<u>Settings</u>

This BCCDC guidance document provides practical information for mental health and substance use (MHSU) inpatient settings for the prevention of COVID-19 and further transmission.

Updated: COVID-19: Viral Testing Guidelines for British Columbia
 BCCDC Guidelines for COVID-19 testing in B.C. are periodically reviewed and updated based on: COVID-19 epidemiology; New clinical information; Current eligibility for treatment; Public health measures in place and more. Updates to this document included: Unvaccinated / partially vaccinated individuals 50 years

and older, fully vaccinated individuals 70 years and older, but have three or more chronic conditions.
