

Checklist

Applies to:	All Medical Students who are supporting the COVID-19 immunization clinics.
Purpose:	To ensure all Pandemic Immunizers are able to safely administer COVID-19 vaccines and are comfortable discussing concerns/misconceptions/questions that clients may have.

How to Use this Checklist

- 1. Print a copy of this document and check the boxes as you complete/review each item.
- 2. Print a copy of the <u>COVID-19 Immunization Skills Checklist</u>.
- 3. Bring your checklists to the immunization evaluator (i.e., experienced immunizer) on your first clinic shift. They will review and complete them with you, and ensure you are paid for your education time.

Note: The <u>Provincial Health Officer (PHO) Orders on March 24th</u> require that Medical Students "must be supervised by a registrant who is authorized under a health profession regulation, and competent, to perform the Immunization Activity". Please ensure you let the clinic lead know if you require supervision.
